

OAK CREEK WATER COMPANY NO. 1

IMPORTANT NOTICE REGARDING AN INCREASE IN UTILITY RATES

Oak Creek Water Co. No. 1 filed an application with the Arizona Corporation Commission (ACC) on May 20, 2016 for an increase in water revenues. The Company's last increase was effective December 1, 2008. At its Open Meeting on October 27, 2016, the ACC approved the following rates and charges.

The recent approval will increase the monthly bill for a residential customer with a 3/4-inch meter using an average of 6,576 gallons per month by \$8.69, from \$21.10 to \$29.79, or 43.9 percent. The exact increase in your monthly bill will vary depending on the customer class to which you belong, the amount of your monthly consumption, and the size of your water meter. Per Decision No. 75810, the following rates and charges will be effective for all services provided on or after November 1, 2016.
